Re: Exámenes de audiometría y visiometría

Estimados padres/tutores,

El Departamento de Salud comenzará el ciclo de exámenes de audiometría y visiometría para los estudiantes. Estos exámenes son exigidos por la ley estatal para todos los estudiantes en los grados Kindergarten, 1ro, 3ro, 4to y 5to. Son gratuitos y se realizarán durante la jornada escolar.

Los exámenes ayudarán a detectar trastornos de audición y visión que pudiesen dificultar el aprendizaje de los estudiantes, los que al detectarse tempranamente son más fáciles de tratar. Los exámenes de audiometría y visiometría serán realizados por asistentes de salud escolar capacitados. Si se sospecha que hay un problema, se realizará una segunda prueba. Si un estudiante no pasa el examen de audición y/o visión, se enviará una carta a casa y el estudiante tendrá que hacer un seguimiento con su médico.

Re: Hearing and Vision Screening

Dear Parents/Guardians,

The Health Department will start conducting hearing and vision screenings for students. Hearing and vision screening are required by State law¹ for all students in grades Kindergarten, 1st, 3rd, 4th, and 5th. These screenings are **free** and will be done during the school day.

These screenings help detect hearing and vision problems that may make it harder for students to learn. By finding hearing and vision problems earlier, they can be easier to treat. Hearing and vision screenings will be done by trained School Health Assistants. If a problem is suspected, a second screening will be done. If a student does not pass the hearing and/or vision screening, a letter will be sent home and the student will need to follow-up with their doctor.
