Mr. Wilcox states the policy must be updated yearly, so all this feedback coming in regarding the policy could be considered during the review/revision policy is very helpful. Dr. Yarborough states the policy review should be expedited to be ready in time for school.

Mr. Mike Carter stated he will confer with the Food Service team of both Baron Young and Jennifer Punzo to better understand the current structure and what needs to change to better communicate and ensure compliance and effectiveness of to protocols going forward.
