The evaluation team consist of the Building Leader with a team, which may consist of other NHPS staff, parents and community members. APT raters observe and score staff interactions (manner, affect, and tone of voice) with youth and families. The observers rate areas such as:
 - 1. Are staffs greeting students and families
 - 2. Transitioning of students
 - 3. Does the space provide appropriate room for all youth and staff?
 - 4. The ability of staffs to communication with youth and/or their families in their language(s).
 - 5. The support staff provide in assisting youth with organizing and preparing themselves to do their homework.
 - 6. Staffs adjustments and accommodations for students based on their experiences and needs and that
 - 7. Staffs use of simple reminders and redirection to support positive behaviors.

AGREEMENT By And Between The New Haven Board of Education AND

This Agreement entered into on the 21 day of November 2023, effective (<u>no sooner than the day after Board of Education Approval</u>), the 12 day of December 2023, by and between the New Haven Board of Education (herein referred to as the "Board" and, Movimiento Cultural Afro Continental, INC located at, 139 Dover Street, New Haven, CT 05413 (herein referred to as the "Contractor".

Compensation: The Board shall pay the contractor for satisfactory performance of services required the amount of \$597.00 per session, for a total of 20 sessions.

The maximum amount the contractor shall be paid under this agreement: Eleven Thousand, Nine Hundred and Forty Dollars (\$11,940.00). Compensation will be made upon submission of <u>an</u> itemized invoice which includes a detailed description of work performed and date of service.

Fiscal support for this Agreement shall be by Title 1 Program of the New Haven Board of Education, Account Number: 2531-5201-56694 Location Code: 0444.

This agreement shall remain in effect from 12/12/2023 to 06/30/2024

HOLD HARMLESS: The Contractor shall insure and/or indemnify the Board and its members, employees and agents against all claims, suits, and expenses, including reasonable attorney's fees, in connection with loss of life, bodily injury or property damage arising from any neglect act or omission of the Contractor or its employees or agents. Further, the Contractor covenants and agrees that it shall hold the Board and its members, employees and agents harmless against any and all claims, suits judgments of any description whatsoever caused by the Contractor' breach of this agreement or based upon the conduct of the Contractor, or its agents or its employees or arising out of in connection with their activities under this agreement.

TERMINATION: The Board may cancel this agreement for any reason upon thirty (30) days' written notice sent to the Contractor by certified U.S. mail, return receipt requested; provided however, that the Board shall be responsible to the Contractor for all services rendered by the Contractor through the last day of thirty (30) day notice period, as long as the Agreement was approved by the Board prior to the start date of service.

EXHIBIT B

STUDENT DATA PRIVACY AGREEMENT SPECIAL TERMS AND CONDITIONS

For the purposes of this Exhibit B "directory information," "de-identified student information," "school purposes," "student information," "student records," "student- generated content," and "targeted advertising" shall be as defined by Conn. Gen. Stat.§10-234aa.

- 1. All student records, student information, and student-generated content (collectively, "student data") provided or accessed pursuant this Agreement or any other services agreement between the Parties are not the property of, or under the control of, the Contractor.
- 2. The Board shall have access to and the ability to delete student data in the possession of the Contractor except in instances where such data is (A) otherwise prohibited from deletion or required to be retained under state or federal law, or (B) stored as a copy as part of a disaster recovery storage system and that is (i) inaccessible to the public, and (ii) unable to be used in the normal course of business by the Contractor. The Board may request the deletion of any such student information, student records or student-generated content if such copy has been used by the operator to repopulate accessible data following a disaster recovery. The Board may request the deletion of student data by the contractor within two (2) business days of receiving such a request and provide to the Board confirmation via electronic mail that the student data has been deleted in accordance with the request, the date of its deletion, and the manner in which it has been deleted. The confirmation shall contain a written assurance from the Contractor that proper disposal of the data has occurred in order to prevent the unauthorized access or use of student data and that deletion has occurred in accordance with industry standards/practices/protocols.
- 3. The Contractor shall not use student data for any purposes other than those authorized pursuant to this Agreement.
- 4. A student, parent or legal guardian of a student may review personally identifiable information contained in student data and correct any erroneous information, if any, in such student data. If the Contractor receives a request to review student data in the Contractor's possession directly from a student, parent, or guardian, the Contractor agrees to refer that individual to the Board and to notify the Board within two (2) business days of receiving such a request. The Contractor agrees to work cooperatively with the Board to permit a student, parent, or guardian to review personally identifiable information in student data that has been shared with the Contractor, and correct any erroneous information therein.

- 5. The Contractor shall take actions designed to ensure the security and confidentiality of student data.
- 6. The Contractor will notify the Board, in accordance with Conn. Gen. Stat. § 10-234dd, when there has been an unauthorized release, disclosure or acquisition of student data. Such notification will include the following steps:

Upon discovery by the Contractor of a breach of student data, the Contractor shall conduct an investigation and restore the integrity of its data systems and, without unreasonable delay, but not more than thirty (30) days after such discovery, shall provide the Board with a more detailed notice of the breach, including but not limited to the date and time of the breach; name(s) of the student(s) whose student data was released, disclosed or acquired; nature of and extent of the breach; and measures taken to ensure that such a breach does not occur in the future.

- 7. Student data shall not be retained or available to the Contractor upon expiration of the contract between the Contractor and Board, except a student, parent or legal guardian of a student may choose independently to establish or maintain an electronic account with the Contractor after the expiration of such contract for the purpose of storing student-generated content.
- 8. The Contractor and Board shall each ensure their own compliance with the Family Educational Rights and Privacy Act of 1974, 20 U.S.C. § 1232g, as amended from time to time.
- 9. The Contractor acknowledges and agrees to comply with the above and all other applicable aspects of Connecticut's Student Data Privacy law according to Connecticut General Statutes §§ 10-234aa through 10-234dd.
- 10. The Parties agree that this Agreement controls over any inconsistent terms or conditions contained within any other agreement entered into by the Parties concerning student data.

Movimiento Cultural Afro-Continental (MCAC), Inc., is a 501c3, not for profit cultural and educational organization based in the Fair Haven neighborhood of New Haven. Since our legal incorporation in 2015, our mission has been to promote and educate Connecticut about the rich African based heritage and folklore through Bomba, which is the oldest Puerto Rican/Caribbean dance and music style rooted in resistance and dating back to the days of slavery.

During the first school semester in 2023, MCAC successfully provided artistic first-hand lessons to over 35 students on the Saturday's Academy at the Fair Haven Middle School. The curriculum focused on educating our students about Puerto Rico's rich African-based folklore found in bomba music, dance and storytelling. The objective was for students to learn and develop an understanding of the Bomba genre in relation to history and how this Afro-Puerto Rican/Caribbean heritage is an integral part of the culture. These students had the opportunity to demonstrate and showcase their artistic lessons learned at two major community civic events; The Fair Haven Day Festival in May 2023 and the Clinton School STREAM Family Carnival in June 2023.

MCAC, Inc. curriculum and workshop lessons are designed to address the core values described in the New Haven Public School Strategic Plan for 2020-2024. MCAC leadership have decades of experience and expertise in providing this type of cultural lessons no commonly found in the educational curriculum.

This proposal will serve 200 to 300 students and faculty during the New Haven Public School semester or calendar year.

PROJECT OVERVIEW

The City of New Haven has neighborhoods such as Fair Haven and the Hill, that are prominently black and brown living in poverty and low-income levels. MCAC, Inc., objective in providing relevant artistic lesson to these neighborhoods are within the strategic plan of the City of New Haven Cultural Equity Plan. Each lesson that we provide is built to enhance participant's artistic skills, self-confidence, and cultural pride. The goal is to have our students participate in public events such as the Fair Haven Day



Festival, The Puerto Rican United Festival, the Clinton School STREAM Family Carnival, and other civic events throughout the year. Our curriculum will cover topics such as, history behind Bomba, lessons on percussion and dance movements techniques, as well as storytelling songs.

U.S. Senator Christopher S. Murphy, in a *Certificate of Accomplishment, presented to Kevin Diaz, in January 18, 2023*, wrote: "This process and expression through the arts enriches the minds and lives of everyone, revealing our shared humanity through the creative process".

Most recently during Hispanic Heritage Month at our bomba workshop to Central Connecticut State University, in New Britain, a participating student wrote to us "Dear Movimiento Cultural Team, I just wanted to extend a very big thank you for coming to our school. This workshop meant a lot to me as I am relearning my roots, more specifically my Puerto Rican roots. I am intrigued with learning more about Bomba and God willing venturing on an opportunity to become an apprentice" ...

SCOPE OF WORK

The cost per each workshop (avrg.1hr to 2.5hrs) is \$597, this will include; three (3) instructors artists stipend, printing materials, hand-crafted traditional instruments, and traditional bomba costumes. All of the funds will directly apply to operating these workshops.
