HSC students will be trained as N4 story exchange facilitators, will work with N4 to lead a story exchange and empathy summit at HSC for HSC students and students from other NHPS schools, and will work with N4 to run a schoolwide story exchange at HSC building off of the success of our 2023 schoolwide story exchange. Guest artists will perform at the summit and schoolwide story exchange.

Please attach a copy of the contractor's resume if an individual or link to contractor website if a company: The story exchange is a unique model for promoting empathy. Participants form small groups (~10 people) led by trained Narrative 4 facilitators. The members of the group pair off and each shares a personal story (usually related to a provided prompt). When they return to the circle, Person A tells Person B's story in the first person ("Hi, I'm Person B," says Person A) and then Person B tells Person A's story in the first person. This methodology is unique because it allows participants to publicly step into their partner's perspective, and the partner gets to experience their own story from the

outside. Further, Narrative 4 facilitators are trained to support people as they share, listen, and--at times--struggle during this experience. They are trained and experienced in managing challenging conversations and keeping participants emotionally safe throughout the experience and in teaching new facilitators these skills. Creating supportive relationships and skill-building to foster resiliency to help children manage stress is a STRONG intervention per the CTSDE ESSA Evidence-Based Guide for Culture & Climate. This event is designed to build relationships and provide students with practice using their voices to connect with others.

 - c. How is this service aligned to the District Continuous Improvement Plan? Goal 3: Development of the Whole Child: this event supports the social-emotional wellness of the whole child.
- Why do you believe this Agreement is fiscally sound? The expected impact on attendance and more successful behavioral supports for students justifies the cost.

From [Promoting Empathy in Adolescents: An Exploratory Study of the Story Exchange](#) (Frausel et al.), *Journal of Character Education*, 2022:

- Schools that used the Narrative 4 model demonstrated increased attendance rates
- Schools that used the Narrative 4 model demonstrated increased graduation rates
- Schools that used the Narrative 4 model demonstrated decreased rates of suspension
- "Regardless of baseline empathy level, students perceived their partner as more similar to themselves after the story exchange, gains maintained after 10 days

From [How do U.S. high school students feel at school? School Report: Emotional Revolution Survey Results: N4 Schools](#) (Brackett et al.), Yale Center for Emotional Intelligence:

- Schools that used the Narrative 4 model demonstrated improved communication skills
- Schools that used the Narrative 4 model demonstrated more positive relationships with teachers
- Schools that used the Narrative 4 model demonstrated feeling that teachers know their interests
- "The students at the N4 Schools experienced all positive emotions more frequently than the national sample."
- "On average, the students in the N4 Schools experienced beneficial experiences more frequently than students in the national sample"
- "The most frequent beneficial experience was having the confidence of being able to do well if putting enough effort into the schoolwork (experienced on average 79.8% of the time in the N4 Schools). Also frequently, the N4 Schools students experienced learning about communication skills (62.9% – 68.8%). Positive relations to teachers were also experienced often in the N4 Schools: 69.7% of the time students felt that there was an adult they could go to if they had a personal problem, and 69.5% of the time they felt that at least one teacher knew their interests."
- "Two experiences that can hinder learning and well-being were less frequent in the N4 Schools than in the national sample. For instance, students in the N4 Schools felt less often than students in the national sample that other people had been mean and cruel to them (less than 30.0% of the time in the N4 Schools) [. . .] The experience that bullying at school was also rare (less than 35.0% of the time at N4 Schools)."
- "While the story exchange's adaptability and ease of administration makes it useful for students in all grade levels, it might be particularly so for adolescent. Bullying, peer pressure, and in/out-group dynamics gain momentum during this period, with potential lifelong consequences (e.g., Erikson, 1959; Qin et al., 2008). Implementation of story exchanges in the often socially-charged period of adolescence could help ameliorate potential conflicts and ostracization by increasing understanding and social connections."

12. What are the implications of not approving this Agreement? While HSC will continue to work to decrease our absenteeism, events like these provide a much-needed boost to our daily efforts. These events will engage students and validate that their school cares very much about who they are as individuals and wants them to use their voices to share their stories and their truth.

High School in the Community (HSC)

This Agreement entered into on the 13 day of February, 2024, effective (*no sooner than the day after Board of Education Approval*), the 30 day of June, 2024, by and between the New Haven Board of Education (herein referred to as the “Board” and, Narrative 4 located at, 1178 Broadway, 3rd floor, New York, NY 10001 (herein referred to as the “Contractor”).

Compensation: The Board shall pay the contractor for satisfactory performance of services required the amount of \$19,940 for three workshops priced at \$1170 (facilitator training for HSC students), \$5550 (HSC/Narrative 4 Summit), and \$13,420 (schoolwide story exchange).

The maximum amount the contractor shall be paid under this agreement: nineteen-thousand, nine-hundred, and forty dollars (\$19,940). Compensation will be made via two invoices: 1) an invoice to be issued on the date of the second event (3/28/24) for 50%, \$9970, and 2) an invoice to be issued on the date of the final event (4/12/24) for 50%, \$9970.

Fiscal support for this Agreement shall be by SIG Program of the New Haven Board of Education, **Account Number:** 2531-6393-56694 **Location Code:** 0066.

This agreement shall remain in effect from 13 February 2024 to 30 June 2024.

Narrative 4 will offer a series of events in partnership with HSC to build empathy, a sense of belonging, and leadership skills. HSC students will be trained as N4 story exchange facilitators, will work with N4 to lead a story exchange and empathy summit at HSC for HSC students and students from other NHPS schools, and will work with N4 to run a schoolwide story exchange at HSC building off of the success of our 2023 schoolwide story exchange. Guest artists will perform at the summit and schoolwide story exchange.

APPROVAL: This Agreement must be approved by the New Haven Board of Education *prior to service start date*. Contactors may begin service no sooner than the day after Board of Education approval.

HOLD HARMLESS: The Contractor shall insure and/or indemnify the Board and its members, employees and agents against all claims, suits, and expenses, including reasonable attorney's fees, in connection with loss of life, bodily injury or property damage arising from any neglect act or omission of the Contractor or its employees or agents. Further, the Contractor covenants and agrees that it shall hold the Board and its members, employees and agents harmless against any and all claims, suits judgments of any description whatsoever caused by the Contractor' breach of this agreement or based upon the conduct of the Contractor, or its agents or its employees or arising out of in connection with their activities under this agreement.

TERMINATION: The Board may cancel this agreement for any reason upon thirty (30) days' written notice sent to the Contractor by certified U.S. mail, return receipt requested; provided however, that the Board shall be responsible to the Contractor for all services rendered by the Contractor through the last day of thirty (30) day notice period, as long as the Agreement was approved by the Board prior to the start date of service.

EXHIBIT B

STUDENT DATA PRIVACY AGREEMENT SPECIAL TERMS AND CONDITIONS

For the purposes of this Exhibit B "directory information," "de-identified student information," "school purposes," "student information," "student records," "student-generated content," and "targeted advertising" shall be as defined by Conn. Gen. Stat. §10-234aa.

1. All student records, student information, and student-generated content (collectively, "student data") provided or accessed pursuant this Agreement or any other services agreement between the Parties are not the property of, or under the control of, the Contractor.
2. The Board shall have access to and the ability to delete student data in the possession of the Contractor except in instances where such data is (A) otherwise prohibited from deletion or required to be retained under state or federal law, or (B) stored as a copy as part of a disaster recovery storage system and that is (i) inaccessible to the public, and (ii) unable to be used in the normal course of business by the Contractor. The Board may request the deletion of any such student information, student records or student-generated content if such copy has been used by the operator to repopulate accessible data following a disaster recovery. The Board may request the deletion of student data by the contractor within two (2) business days of receiving such a request and provide to the Board confirmation via electronic mail that the student data has been deleted in accordance with the request, the date of its deletion, and the manner in which it has been deleted. The confirmation shall contain a written assurance from the Contractor that proper disposal of the data has occurred in order to prevent the unauthorized access or use of student data and that deletion has occurred in accordance with industry standards/practices/protocols.
3. The Contractor shall not use student data for any purposes other than those authorized pursuant to this Agreement.
4. A student, parent or legal guardian of a student may review personally identifiable information contained in student data and correct any erroneous information, if any, in such student data. If the Contractor receives a request to review student data in the Contractor's possession directly from a student, parent, or guardian, the Contractor agrees to refer that individual to the Board and to notify the Board within two (2) business days of receiving such a request. The Contractor agrees to work cooperatively with the Board to permit a student, parent, or guardian to review personally identifiable information in student data that has been shared with the Contractor, and correct any erroneous information therein.

5. The Contractor shall take actions designed to ensure the security and confidentiality of student data.
6. The Contractor will notify the Board, in accordance with Conn. Gen. Stat. § 10-234dd, when there has been an unauthorized release, disclosure or acquisition of student data. Such notification will include the following steps:

Upon discovery by the Contractor of a breach of student data, the Contractor shall conduct an investigation and restore the integrity of its data systems and, without unreasonable delay, but not more than thirty (30) days after such discovery, shall provide the Board with a more detailed notice of the breach, including but not limited to the date and time of the breach; name(s) of the student(s) whose student data was released, disclosed or acquired; nature of and extent of the breach; and measures taken to ensure that such a breach does not occur in the future.

7. Student data shall not be retained or available to the Contractor upon expiration of the contract between the Contractor and Board, except a student, parent or legal guardian of a student may choose independently to establish or maintain an electronic account with the Contractor after the expiration of such contract for the purpose of storing student-generated content.
8. The Contractor and Board shall each ensure their own compliance with the Family Educational Rights and Privacy Act of 1974, 20 U.S.C. § 1232g, as amended from time to time.
9. The Contractor acknowledges and agrees to comply with the above and all other applicable aspects of Connecticut's Student Data Privacy law according to Connecticut General Statutes §§ 10-234aa through 10-234dd.
10. The Parties agree that this Agreement controls over any inconsistent terms or conditions contained within any other agreement entered into by the Parties concerning student data.



NARRATIVE 4

High School in the Community Scope of Services Spring 2024

Statement of Work:

Narrative 4 is thrilled to continue our partnership with High School in the Community (HSC) during the 2023-2024 school year. This spring, we will expand on the foundational work we've previously done with HSC by adding additional events and training for their students.

The Narrative 4 mission is to break down barriers and shatter stereotypes by using the power of stories, art and education to equip young people to become powerful forces of change in society. Our vision is to create the world's largest community where every young adult leads with empathy.

Event Descriptions:

Narrative 4 and HSC are planning three (3) events this spring which will not only add an opportunity for leadership training for a cohort of HSC students but will engage with the larger New Haven community and will culminate with a schoolwide Story Exchange for the entire HSC student body.

- Event 1: Narrative 4 Facilitator Training for 15-20 selected HSC students on Friday, 2/23/24
- Event 2: HSC Narrative 4 Summit, bringing approximately 50 students from multiple New Haven Public Schools together for an artist workshop and inter-school Story Exchange on Thursday, 3/28/24 hosted by High School in the Community and facilitated by student leader facilitators from HSC with additional N4 staff acting as mentors/co-facilitators with the HSC student leaders
- Event 3: Schoolwide Story Exchange for the entire HSC student body with an artist performance/workshop on Friday, 4/12/24

Narrative 4 Responsibilities:

- Support HSC Magnet Resource Teacher and building leadership to meet our collective goals for both your school and our program.
- N4 Regional Manager and staff will work with HSC Magnet Resource teacher and building leadership to coordinate 2-3 planning meetings prior to the events
- Provide 3 trained N4 Facilitator(s) to lead the Facilitator Training on 2/24; 5 N4 Facilitators for the HSC Summit on 3/28, and approximately 18 N4 Facilitators on 4/12 to lead the Story Exchange for students. N4 Facilitators will co-facilitate but also serve

as mentors/role models for trained HSC students as they lead the events on 3/28 and 4/12.

- Contract and transport a member of N4's Artists Network to provide an engaging, hands-on workshop for attendees to the HSC Summit on 3/28.
- Contract and transport a member of N4's Artists Network who will lead a performance + interactive workshop for all students as the keynote session of the event on 4/12.
- N4 Regional Manager will debrief with both facilitators and HSC building leadership after the events to ensure program goals were met.
- Narrative 4 will conduct post-event evaluations for participants and staff for all events (including but not limited to participants numbers, staff/faculty feedback and observations)

High School in the Community Responsibilities:

- Attend all trainings and meetings scheduled with N4 program representatives to ensure the success of the event
- Provide facilities and spaces for all activities during the events which include:
 - One large room for training on 2/24, with access to screen/projector
 - One large gathering room for HSC Summit on 3/28 and breakout spaces for 5 groups
 - One large gathering space and breakout rooms for up to 20 groups for the schoolwide Story Exchange on 4/12
 - Any necessary audio/visual technology needs such as projectors/screens, speakers, microphones, etc.
- Communicate with all participants prior to the event about the format and expectations of the events, especially the story exchange and the prompts
- Support Narrative 4 staff in the collection of qualitative and quantitative data
- If agreed upon, help promote these events to local press and the larger New Haven community
- Maintain consistent communication with N4 program representatives and help troubleshoot any obstacles that arise

While all else remains the same, this sole source expires five years from the date of this letter.

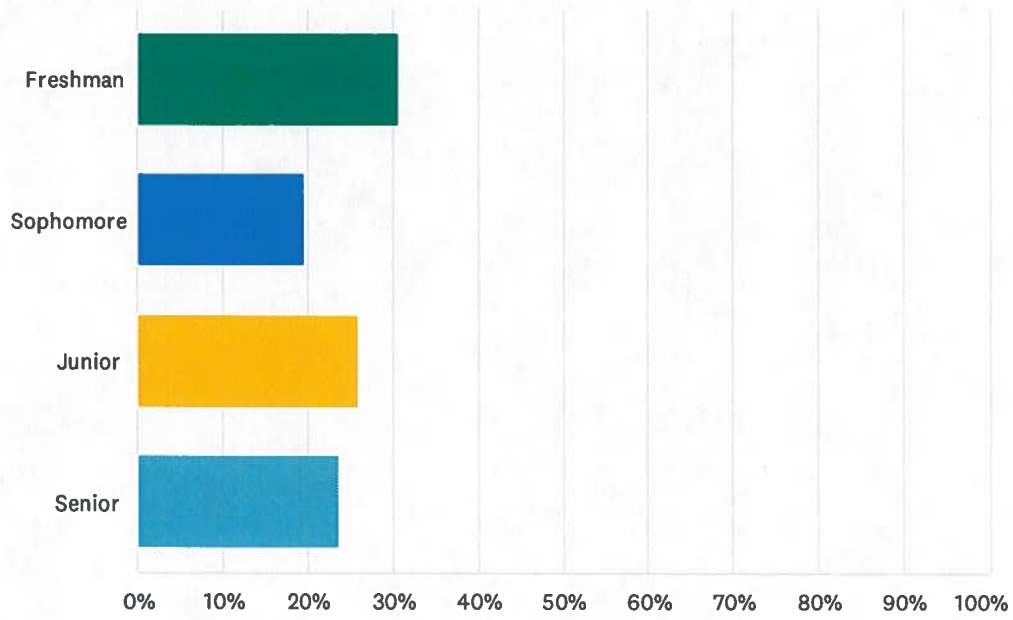

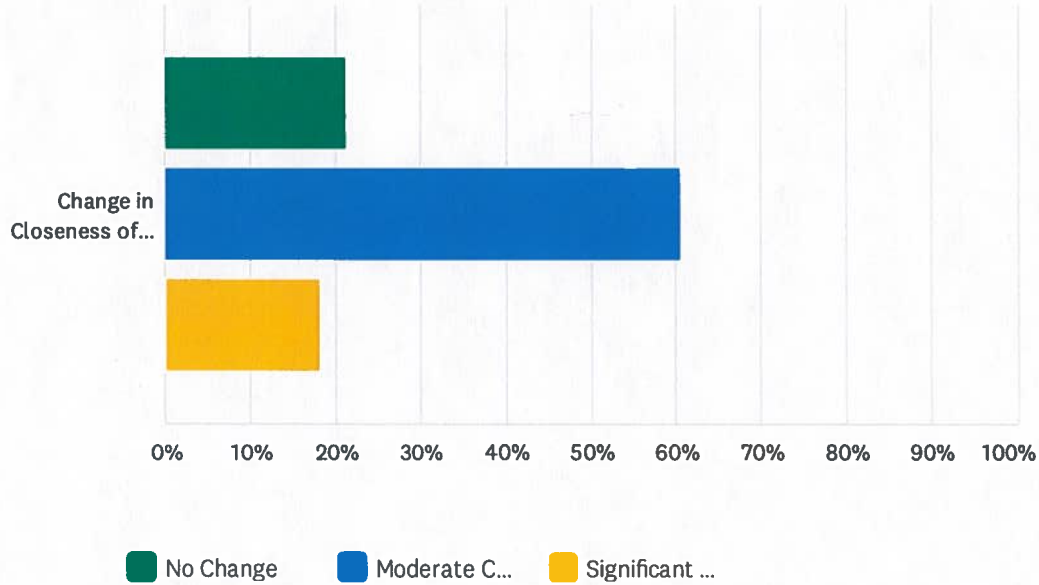

Q2 Please select the answer below that best describes how the relationship between you and your partner was affected by the Story Exchange.

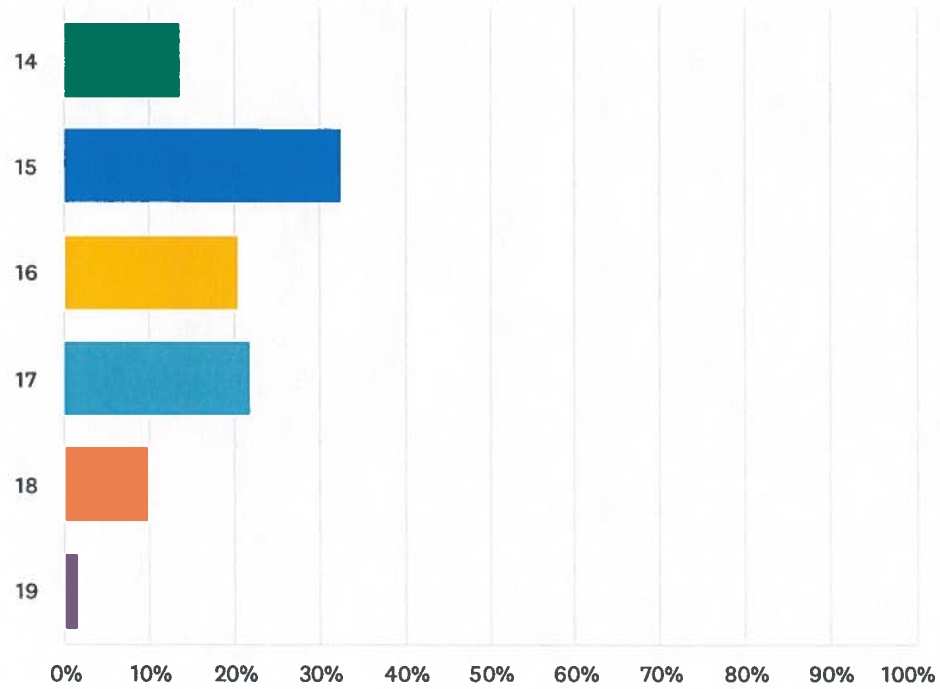

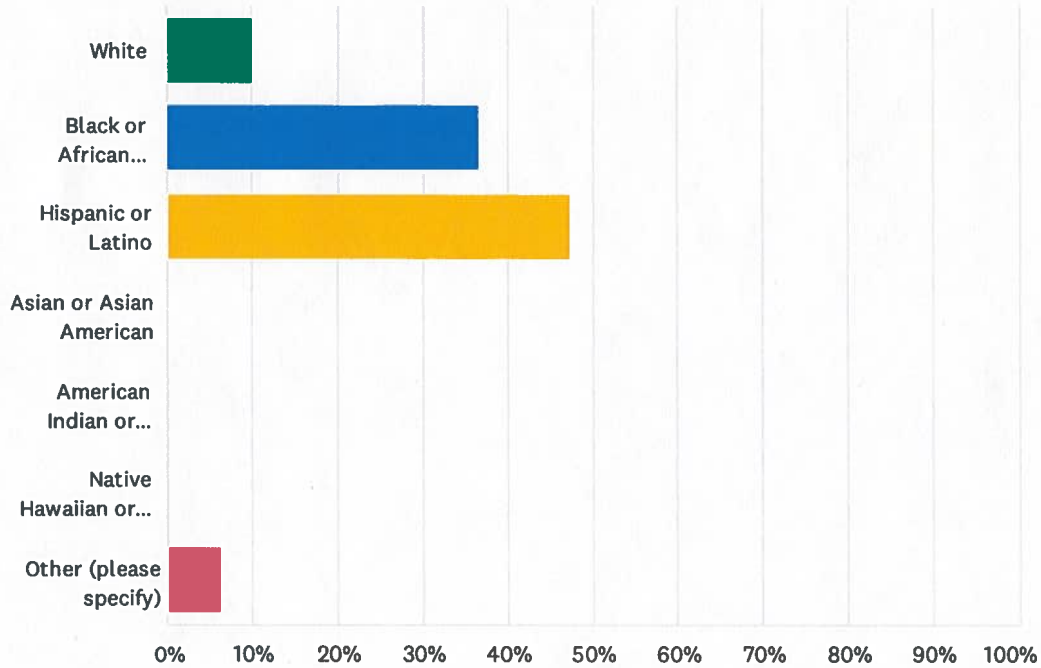

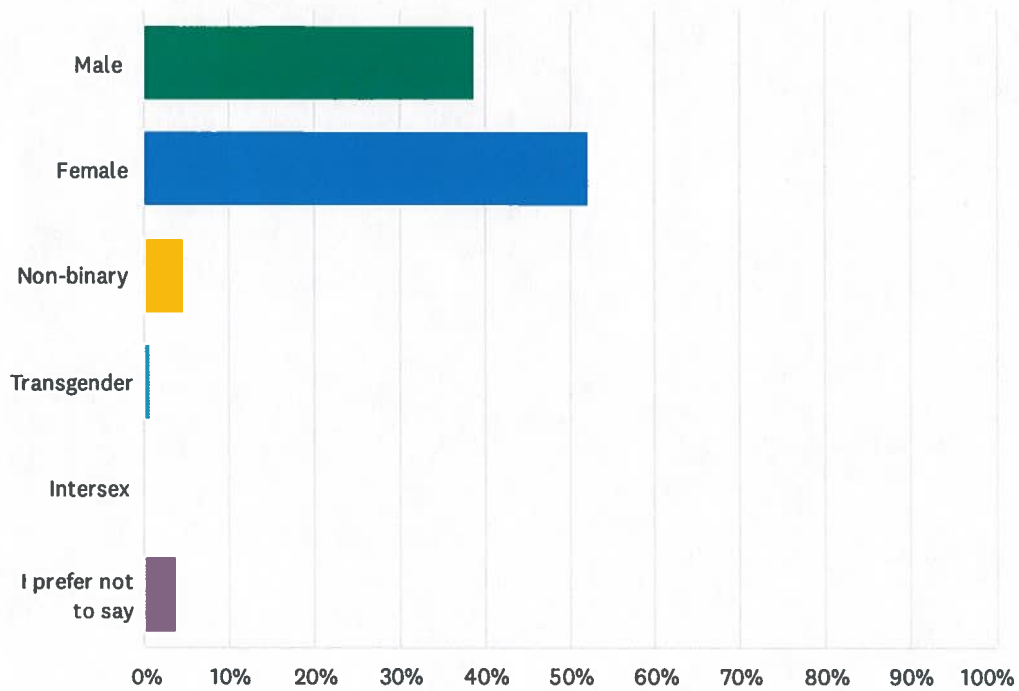

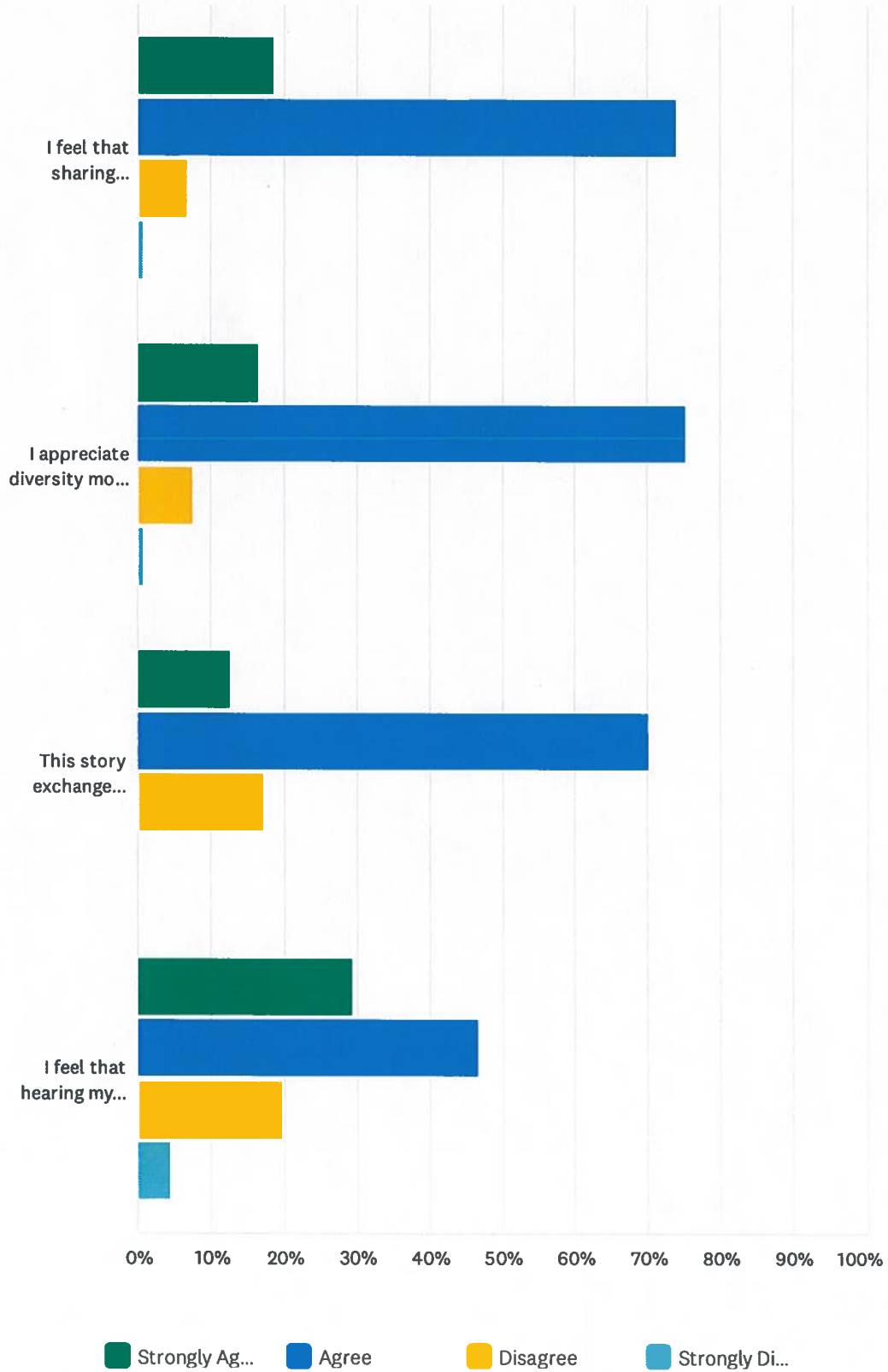
